Part of the health IT certification includes MD Toolbox, E-fax, Dosespot, Ringcentral and Amazon chime which are optional services, may billed at vendor cost. Novoclinical does not charge additional fees for the development or configuration of interfaces or health information exchange integration that are required to meet Meaningful Use requirements. Other health care trading partners and vendors may charge Novoclinical clients for the creation, development, and maintenance of interface or health information exchange integration. Clients that elect to use services above and beyond requirements to meet Meaningful Use may pay additional fees.

Other Contractural/Technical details

- **Software Licenses:** The cost of Novoclinical EHR software is determined by the number of providers (MD, DO, PA, NP, PT, OD, DPM) and number of site locations. Based upon these factors the cost is generated. Monthly subscription fees are included in the customer agreement.
- **Software Training:** There is a per-cost per day charge for onsite training (plus travel expenses) and or remote software training provided by an corporate trainer.
- **HL7 Interfaces:** Novomedici LLC reserves the right to charge a fee for all HL7 (3rd party) interfaces including an ongoing support fee to support the interface. All upfront HL7 fees including any monthly HL7 support fees deemed to be the responsibility of the customer will be outlined in the Novomedici LLC customer agreement.
- **Software Maintenance:** Novomedici LLC does not charge any extra for the software maintenance.
- **Data Export:** Novomedici LLC will charge a fee to export health data out of the Novomedici LLC EHR software in the event the customer requires data to transfer to another EHR.
- **Third party software/service:** Most of the third-party services are part of the software license and Novomedici LLC does not charge separately. But Novomedici LLC reserves the right to charge or add a fee incase the third-party service changes their cost/fee; customers will be notified and a agreement will be placed before charging any additional costs to the customers.
